Eastern Metals Limited – (ASX: EMS) – Anticipated Reinstatement to Quotation

Description

It is anticipated that the securities of Eastern Metals Limited ('EMS') will be reinstated to quotation at 09:59:00 AM (+/- 15 seconds) AEDT on Friday, 9 January 2026, following its re-compliance with Chapters 1 and 2 of the ASX Listing Rules.

EMS raised \$5,000,000 pursuant to the offer under its prospectus dated 10 October 2025 (the 'Prospectus') by the issue of 250,000,000 shares at an issue price of \$0.02 per share.
