Types of offers

- A bonus issue (complete Part 2)
- A standard pro rata issue (including nonrenounceable or renounceable) (complete Q1.6a and Part 3)
- An accelerated offer (complete Q1.6b and Part 3)
- An offer of securities under a securities purchase plan (complete Part 4)
- A non pro rata offer of securities under a disclosure document or product disclosure statement (PDS) (complete Part 5)
- A non pro rata offer to wholesale investors under an information memorandum (complete Part 6)
- A placement or other type of issue (complete Part 7)

Typical Parts to be completed for each offer*

- Conditions
- Issue or Offer details
- Timetable
- Listing Rule requirements
- Lead Manager/Broker & Underwriter details
- Further information

*some exceptions depending on the type of offer



Appendix 3B – Notification of proposed issue of securities

Re-cap on Appendix 3B offer types / relevant part in online form

Participating and Proposed Securities – Part B for each type of offer

Presentation of questions in online form

Participating security	Proposed Security	Attaching Security
i.e. holders of which security can participate in the offer	Can have 1 proposed security per 1 participating security	Can have 1 or more attaching securities (usually free options) per 1
Can have more than 1 participating security		proposed security

Caters for offers where either existing or new class of security is proposed to be issued

Additional question re whether the entity has quoted company options – do the terms entitle option holders to participate on exercise

 - Additional question (word form 8A.2) "are any on-sale of the securities" where applicable, additional question in "Further information" part in online form
 - Amended explanatory note (end Part 8A in word form) visible under "Details of securities proposed to be issued" in online form
